**NATURE OF REQUEST:**

The Traffic Engineering Committee received a neighborhood petition to install residential parking (Type B) on the east and west side of 37<sup>th</sup> Street between 12<sup>th</sup> and 14<sup>th</sup> Avenue.

**CONTACTS WITH RESIDENTS:**

A neighborhood petition was submitted.

**TRAFFIC STUDY INFORMATION:**

Residential Parking Type B Area—The resident or residents of a dwelling unit which abuts or is adjacent to a designated residential parking only area may obtain from the Finance Department of the City, by payment of a five dollar (\$5.00) fee, a parking permit for each owned, leased, rented or assigned vehicle. This permit will allow parking in any otherwise legal parking space within the designated area. These permits shall not be transferable to other vehicles.

Each resident issued a parking permit will also receive without additional fee two (2) visitor parking permits which may be displayed only upon vehicles not registered to residents of the dwelling and may be transferred between vehicles. Visitor parking permits may be displayed only on vehicles used by persons not at the home of the resident to whom the permit was issued.

In the event that a resident does not own any vehicles, two (2) visitor permits may be obtained by payment of a five dollar (\$5.00) fee.

**COST:**

The cost to the city is minimal.

**RECOMMENDATION:**

The Traffic Engineering Committee recommends that the City Council approve the installation of residential parking (Type B) on the east and west side of 37<sup>th</sup> Street between 12<sup>th</sup> and 14<sup>th</sup> Avenue and consider the ordinance.

**A SPECIAL ORDINANCE  
ESTABLISHING A TYPE B RESIDENTIAL PARKING ONLY AREA  
IN THE CITY OF ROCK ISLAND, ILLINOIS**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCK ISLAND, ILLINOIS:

Section One. That the parking area on the east and west side of 37<sup>th</sup> Street between 12<sup>th</sup> and 14<sup>th</sup> Avenue in the City of Rock Island, Illinois, be and is hereby determined to be a Type B residential permit parking only area pursuant to the provisions of Chapter 9, Article II, Division 5, Sections 9-97.1 through 9-100 of the Code of Ordinances of the City of Rock Island, Illinois.

Section Two. All ordinances and parts of ordinances in conflict herewith are hereby repealed insofar as they do so conflict.

Section Three. This ordinance shall be in full force and effect 10 days from its passage and approval, as required by law.

## Residential Parking Permit

Residents that would like residential permit parking will need to submit a petition that must be signed by residents representing two-thirds (2/3) of the dwelling units in the proposed area.

The cost of a Residential Parking Permit is \$5 per year for each owned, leased, rented or assigned vehicle and is applicable only to the designated street. These permits shall not be transferable to other vehicles. Each resident issued a Residential Parking Permit will also receive without additional fee two (2) Visitor Parking Permits which may be displayed only upon vehicles not registered to residents of the dwelling and may be transferred between vehicles. In the event that a resident does not own any vehicles, two (2) Visitor Parking Permits may be obtained by payment of a \$5 annual fee.
