

A SPECIAL ORDINANCE
 AMENDING CHAPTER 16 OF THE CODE OF ORDINANCES
 ESTABLISHING A WATER RATE INCREASE
 IN THE CITY OF ROCK ISLAND, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCK ISLAND, ILLINOIS:

Section One: Pursuant to the provisions of Chapter 16, Article III, Section 16-34 of the Code of Ordinances of The City of Rock Island, Illinois, water rates in said City be and are hereby as set out below.

Section Two: That Section 16.34 is hereby amended by deleting subsections (a) and (b) in their entirety and inserting water rates as set forth below. The new 2021 rates are effective September 1, 2021 all other yearly rate increases become effective January 1, of that calendar year:
